GPHR ELIGIBILITY REQUIREMENTS CHANGING IN YEAR 2011

To be eligible to take the GPHR exam, the Human Resource Certification Institute (HRCI) currently requires a professional to have at least 2 years of exempt-level HR work experience. Effective 2011, the GPHR eligibility requirements will include at least two years of global exempt-level experience.
